

**NJCAA Region 16 Sports Codes  
Men's Basketball - Division 2  
September 28, 2012**

- A. Selection of chair: Region director selects chair and AD liaison.
- B. Selection of Coach of the Year. The Region winner is Coach of the Year.
- C. Selection of Region competition site. The Region tournament site will be selected by a draw of participating institutions. (Draw results for tournament host conducted at 2012 Spring Region Meeting: 2013-Penn Valley, 2014-Wentworth, 2015-St. Louis, 2016-North Central.)
- D. Award policy: First place team award. Fifteen individual awards are given to the championship team. Ten individual plaques are given for the All Region team. If there is a tie, each member of the All Region team will be given a plaque. Certificates will be awarded to any possible All Region Honorable Mention selections.
- E. All Region selections: The AD liaison will mail a nomination form, followed by a voting ballot, to all D2 head coaches. Coaches may nominate up to five of their own players. Region director or liaison handles voting. Coaches may nominate only their own players. Coaches cannot vote for their own players. The top ten vote getters are selected. If there is a tie, the players that tie for the tenth spot on the All Region team will be re-voted on by the coaches. A plaque will be awarded to each All Region member. A certificate will be awarded to each member that fell short as a result of the re-vote. Those members that receive a certificate will be All Region Honorable Mention. The All Region team announcement will be released to each school at the same time.
- F. All-American nominations: The top two players receiving the most votes will be nominated for NJCAA All-American. Institutions must provide all documentation required by the NJCAA.
- G. Code of Conduct: As appears in the NJCAA Handbook. Addendum: No cutting of the nets.
- H. Regional Tournament
  - a. Seeding: Region XVI Division II AD Liaison will conduct the seeding. Tie breaker criteria:
    - i. Head to head
    - ii. Winning percentage versus Division II opponents outside Region XVI.

iii. Coin flip.

b. Officials: The officials will be selected by a Region 16 representative from either the western side of the state or the eastern side of the state. Each year the selection process responsibility of the officials will alternate to the other side of the state.

c. Type of play: Single elimination

d. Type of ball: NJCAA approved ball.

e. Pre-tournament practice: To be arranged with the tournament host.

f. Filming of opponent games: Not permissible.

g. Scouting information to outside institutions: Scouting information to non-region institutions is prohibited.

h. Financial arrangements: Tournament expenses are pro-rated by games played.

i. Format:

i. Play in game- Tuesday, 7:00 p.m.

ii. Semi-finals- Friday, 5:00 & 7:00 p.m.

iii. Finals- Saturday, 2:00 p.m.
